RESOLUTION AUTHORIZING ENGAGEMENT OF WILSON ELSER MOSKOWITZ EDELMAN & DICKER LLP, AS SPECIAL AGENCY COUNSEL TO ASSIST WITH THE REVIEW OF A PROPOSED MORTGAGE AND RELATED LOAN DOCUMENTS SECURING A PROPOSED LOAN TO MONTREIGN OPERATING COMPANY, LLC ("COMPANY")

WHEREAS, Monticello Raceway Management, Inc., an affiliate of the Company submitted an application ("Application") to the Agency on February 6, 2013, requesting that the Agency undertake a certain project, in one or more phases, for the benefit of the Company consisting of: (i) the acquisition by the Agency of a leasehold interest or other interest in certain

property located at Joyland Road and Thompsonville Road in the Town of Thompson ("Town"), County of Sullivan ("County"), State of New York and being more particularly identified as all or part of tax map numbers 23-1-52.1 and 23-1-48.1 (f/k/a 23-1-11.3, 23-1-48, 23-1-52 (portion), 23-1-53 (portion), 23-1-54.1, 23-1-54.2 (portion), 23-1-54.3 (portion)) and containing in the aggregate approximately 186 acres ("Land"), (ii) the construction and equipping on the Land a "Casino Resort", which will consist of, among other things, a casino, hotel, banquet event center, restaurants, support buildings and structured and surface parking and related facilities and amenities (collectively, the "Improvements"), and (iii) the acquisition in and around the Land and the Improvements of certain items of equipment and other tangible personal property ("Equipment," and collectively with the Land and the Improvements, the "Project); and

WHEREAS, by resolution 09-13 adopted on March 19, 2013, resolution 28-14 adopted on September 3, 2014 and resolution 22-15 adopted September 18, 2015, the Agency approved various forms of financial assistance for the Project, including an exemption from mortgage recording tax on one or more mortgages to secure indebtedness incurred by the Company in connection with the Project; and

WHEREAS, the Company has requested the Agency review and approve the form of one or more mortgages and related loan documents securing a proposed loan to the Company; and

WHEREAS, Garigliano Law Offices, LLP, Agency General Counsel, has requested the Agency authorize engagement of special counsel to assist with contemplated review.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE AGENCY AS FOLLOWS:

- Section 1. The Agency hereby authorizes the engagement of Wilson Elser Moskowitz Edelman & Dicker LLP, as Agency special counsel to assist with the review of a mortgage and related loan documents securing a proposed loan to the Company, with all fees and expenses related thereto to be paid by the Company.
- Section 2. The officers, employees and agents of the Agency are hereby authorized and directed for and in the name and on behalf of the Agency to do all acts and things required and to execute and deliver all such certificates, instruments, documents, and to pay all such fees, charges and expenses and to do all such further acts and things as may be necessary or in the opinion of the officer, employee or agent acting on behalf of the Agency desirable and proper to effect the purposes of the foregoing resolutions and to cause compliance by the Agency with all the terms, covenants and provisions of the documents for and on behalf of the Agency.
- Section 3. These resolutions shall take effect immediately.
