***RESOLUTION THE AGENCY TO APPOINT EDWARD T. SYKES ("SYKES")
AS EXECUTIVE DIRECTOR COMMENCING APRIL 18, 2016***

WHEREAS, the Agency was created by Chapter 560 of the Laws of 1970 of the State of New York, as amended, pursuant to Title I of Article 18-A of the General Municipal Law of the State of New York (collectively, the "Act") as a body corporate and politic and as a public benefit corporation of the State of New York; and

WHEREAS, Jennifer C.S. Brylinski, the former Agency Executive Director retired; and

WHEREAS, the Agency wishes to appoint Mr. Sykes as Executive Director effective as of April 18, 2016 at the salary and with the benefits provided herein.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE AGENCY AS FOLLOWS:

Section 1. The Agency hereby appoints Mr. Sykes as Executive Director effective as of April 18, 2016.

Section 2. Mr. Sykes' compensation shall be as follows:
(a) One Thousand and 00/100 (\$1,000.00) Dollars per week; and
(b) reimbursement of the cost of medical insurance coverage in accordance with the Agency's policy; and
(c) reimbursement for all reasonable and necessary business expenses for representation of the Agency and proof of such expenditures.

Section 3. These resolutions shall take effect immediately.


