RESOLUTION CONSENTING TO ANY OR ALL APPLICATION(S) BY FOUR GOATS LLC ("COMPANY") FOR FUNDING OF WATER QUALITY MAINTENANCE, REPAIRS AND IMPROVEMENTS

WHEREAS, the Agency was created by Chapter 560 of the Laws of 1970 of the State of New York, as amended, pursuant to Title I of Article 18-A of the General Municipal Law of the State of New York (collectively, the "Act") as a body corporate and politic and as a public benefit corporation of the State of New York; and

WHEREAS, on or about December 15, 2015, the Company entered into an (i) Assignment and Assumption of Lease Agreement and Related Documents and Consent of Agency; (ii) Amended and Restated Lease Agreement; and (iii) Amended and Restated Payment in Lieu of Taxation Agreement relating to the premises depicted on the Town of Neversink tax map as Section 35, Block 1 and Lot 8.4 and located at 4 Schumway Road in the Town of Neversink, County of Sullivan, State of New York ("Real Property"); and

WHEREAS, on or about August 18, 2016, New York City Department of Environmental Protection ("NYCDEP") issued a Notice of Violation for a failed subsurface sewage treatment system and for sewage surfacing on the ground on the Real Property; and

WHEREAS, on or about August 22, 2016, NYCDEP issued a Notice of Complete Application together with additional Notice of Violation; and

WHEREAS, certain sources of finding may be available to the Company to pay all or part of the cost of maintenance, repairs and improvements to mitigate and correct the conditions giving rise to the Notice of Violation.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE AGENCY AS FOLLOWS:

- Section 1. The Agency hereby consents to any or all application(s) by the Company for funding of water quality maintenance, repairs and improvements.
- Section 2. The officers, employees and agents of the Agency are hereby authorized and directed for and in the name and on behalf of the Agency to do all acts and things required and to execute and deliver all such certificates, instruments, documents, and to pay all such fees, charges and expenses and to do all such further acts and things as may be necessary or in the opinion of the officer, employee or agent acting on behalf of the Agency desirable and proper to effect the purposes of the foregoing resolutions and to cause compliance by the Agency with all the terms, covenants and provisions of the documents for and on behalf of the Agency.
