These changes include: modifications to permitted uses and special permit uses in every district; modifications to the minimum lot size in the AC district; new cluster (conservation) subdivision regulations; changes to many zoning definitions; changes to site plan and special use permit review; creation of a new wellhead protection overlay district and miscellaneous other items.
