RESOLUTION AUTHORIZING EXECUTION BY THE AGENCY'S CHAIRMAN OF A SECOND AMENDMENT AND EXTENSION TO CONSULTING AGREEMENT BY AND BETWEEN THE AGENCY AND STEVE WHITE ("CONSULTANT") ON THE TERMS AND CONDITIONS SET FORTH HEREIN

WHEREAS, the Agency was created by Chapter 560 of the Laws of 1970 of the State of New York, as amended, pursuant to Title I of Article 18-A of the General Municipal Law of the State of New York (collectively, the "Act") as a body corporate and politic and as a public benefit corporation of the State of New York; and

WHEREAS, the Agency and Consultant entered into a Consulting Agreement, effective as of the 1st day of November, 2014, which was amended and extended (collectively, the "Consulting Agreement"); and

WHEREAS, the Consulting Agreement expired on December 31, 2016; and

WHEREAS, the Agency wishes to extend the Consulting Agreement for an additional one (1) year covering the period January 1, 2017 and ending December 31, 2017.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE AGENCY AS FOLLOWS:

- Section 1. The Agency hereby authorizes the extension of the Consulting Agreement for another one (1) year commencing January 1, 2017 and ending December 31, 2017.
- Section 2. For the calendar year 2017, the Consultant shall be paid compensation in the amount of Seventy Thousand and 00/100 (\$70,000.00) Dollars.
- Section 3. The Chairman of the Agency, is hereby authorized, empowered, and directed, on behalf of the Agency, to execute and deliver the Second Amendment and Extension to Consulting Agreement, in form approved by Counsel to the Agency and with such changes, variations, omissions and insertions as the Chairman of the Agency so executing the same shall approve.
- Section 4. The officers, employees and agents of the Agency are hereby authorized and directed for and in the name and on behalf of the Agency to do all acts and things required and to execute and deliver all such certificates, instruments, documents, and to pay all such fees, charges and expenses and to do all such further acts and things as may be necessary or in the opinion of the officer, employee or agent acting on behalf of the Agency desirable and proper to effect the purposes of the foregoing resolutions and to cause compliance by the Agency with all the terms, covenants and provisions of the documents for and on behalf of the Agency.

Section 5. These resolutions shall take effect immediately.
