Resolution No. 09 - 17

RESOLUTION OF THE AGENCY TO TAKE TITLE TO THE LAND (AS HEREINAFTER DEFINED) FROM THE PRESENT OWNER AS NOMINEE OF CATSKILL HOSPITALITY HOLDING LLC ("CHH")

WHEREAS, by Title 1 of Article 18-A of the General Municipal Law of the State of New York ("State"), as amended, and Chapter 560 of the Laws of 1970 of the State, as amended and codified as Section 960 of the General Municipal Law (collectively, the "Act"), the Agency was created with the authority and power to own, lease and sell property as authorized by the Act; and

WHEREAS, on June 20, 2016, the Agency adopted a resolution approving the Company and CHO, LLC's application to the Agency, a copy of which is on file at the office of the Agency, to undertake a project consisting of the: (i) acquisition, construction, installation and equipping of

an approximately 56,000 square foot building intended to be used as a limited service hotel ("Building") situate on one (1) parcel of real estate consisting of approximately 6.59± acres located along Golden Ridge Road, Town of Thompson, County of Sullivan, State of New York and identified on the Town of Thompson tax map as a portion of Section 13, Block 3, Lot 38.1 ("Land"); (ii) acquisition, construction and equipping of the Building; (iii) acquisition, construction and installation thereon and therein of certain furniture, fixtures, machinery, equipment and tools ("Equipment"); (iv) construction of improvements to the Building, the Land and the Equipment (collectively, the Building, the Land and the Equipment are referred to as the "Facility" or the "Project"); and (v) lease of the Project from the Agency to the Company; and

WHEREAS, the Company is unable to close on the anticipated straight lease transaction with the Agency due to issues associated with project financing; and

WHEREAS, the Company has requested that the Agency take title to the Land from the present owner as nominee of the Company subject to negotiation and execution of preliminary agreement between the Company the Agency under the terms of which (i) the Company shall indemnify the Agency; and (ii) the Agency shall have the right at any time on or after December 31, 2017 to unconditionally transfer title to the Company; and

WHEREAS, the Agency believes that by taking title to the Land as nominee it will induce the Company to finalize the Project financing.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE AGENCY AS FOLLOWS:

- Section 1. The Agency is hereby authorized to take title to the Land from the present owner as nominee of the Company for the purpose of inducing the Company to develop the Project thereby increasing employment opportunities in Sullivan County and otherwise furthering the purpose of the Agency under the Act. The Chairman, Executive Director or Chief Executive Officer of the Agency is hereby authorized, directed and empowered to execute, deliver or accept delivery of any and all documents necessary to carry out the foregoing resolution. The foregoing is subject to negotiation and execution of preliminary agreement between the Company the Agency under the terms of which (i) the Company shall indemnify the Agency and (ii) the Agency shall have the right at any time on or after December 31, 2017 to unconditionally transfer title to the Company.
- Section 2. The officers, employees and agents of the Agency are hereby authorized and directed for and in the name and on behalf of the Agency to do all acts and things required and to execute and deliver all such certificates, instruments, documents, and to pay all such fees, charges and expenses and to do all such further acts and things as may be necessary or in the opinion of the officer, employee or agent acting on behalf of the Agency desirable and proper to effect the purposes of the foregoing resolutions and to cause compliance by the Agency with all the terms, covenants and provisions of the documents for and on behalf of the Agency.

Section 3. These resolutions shall take effect immediately.
