The following resolution was duly offered by Howard Siegel, and seconded by Carol Roig, to wit:

Resolution No. 08 - 18

RESOLUTION AUTHORIZING AND APPROVING A FINANCIAL ASSISTANCE AWARD TO THE ROSCOE NY BEER COMPANY, LLC

WHEREAS, the Agency was created by Chapter 560 of the Laws of 1970 of the State of New York, as amended, pursuant to Title I of Article 18-A of the General Municipal Law of the State of New York (collectively, the “Act”) as a body corporate and politic and as a public benefit corporation of the State of New York; and

WHEREAS, the Agency administers an Agribusiness Revolving Loan and Lease Fund for the purpose of providing financial assistance to Sullivan County agricultural businesses, including craft beverage manufacturers; and

WHEREAS, The Roscoe NY Beer Company, LLC (“RBC”) has requested financial assistance in the form of lease financing for a canning attachment to RBC’s existing Martin Robotics bottling line; and

WHEREAS, the Agency wishes to memorialize its finding that the canning attachment must be secured from Martin Robotics as there is no other supplier of equipment to be efficiently retrofitted to the existing bottling line.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE AGENCY AS FOLLOWS:

Section 1. The Agency hereby approves financial assistance for the benefit of RBC in an amount not to exceed FIFTY-FIVE THOUSAND AND 00/100 (\$55,000.00) DOLLARS with the approved financial award to be used by the Agency to procure a canning attachment to the existing RBC bottling line (“Canning Attachment”) and the lease of the Canning Attachment to RBC.

Section 2. The Agency hereby determines that the sole source of retrofitted equipment to be added to RBC’s existing bottling line is Martin Robotics so that the provisions of the Agency’s Procurement Policy requiring competitive bidding are hereby waived.

Section 3. The Chairman, Vice Chairman, Executive Director and Chief Executive Officer of the Agency are hereby authorized, on behalf of the Agency, to execute and deliver any and all related agreements, certificates, documents and instruments necessary to procure the Canning Attachment and lease the same to RBC under the Agency’s Agribusiness Revolving Loan and Lease Fund program all in the form approved by Counsel to the Agency and with such changes, variations, omissions and insertions as the Chairman, Vice Chairman, Executive Director or Chief Executive Officer of the Agency shall approve, the execution thereof by the Chairman, Vice Chairman, Executive Director or Chief Executive Officer of the Agency to constitute conclusive evidence of such approval.

Section 4. The officers, employees and agents of the Agency are hereby authorized and directed for and in the name and on behalf of the Agency to do all acts and things required and to execute and deliver all such certificates, instruments, documents, and to pay all such fees, charges and expenses and to do all such further acts and things as may be necessary or in the opinion of the officer, employee or agent acting on behalf of the Agency desirable and proper to effect the purposes of the foregoing resolutions and to cause compliance by the Agency with all the terms, covenants and provisions of the documents for and on behalf of the Agency.

Section 5. These resolutions shall take effect immediately.


