***RESOLUTION OF THE AGENCY TO APPOINT EDWARD T. SYKES ("SYKES") AS CHIEF EXECUTIVE OFFICER ("CEO") COMMENCING NOVEMBER 2, 2018***

***WHEREAS***, the Agency was created by Chapter 560 of the Laws of 1970 of the State of New York, as amended, pursuant to Title I of Article 18-A of the General Municipal Law of the State of New York (collectively, the "Act") as a body corporate and politic and as a public benefit corporation of the State of New York; and

***WHEREAS***, Steve White, the Agency's Chief Executive Officer resigned as CEO effective today; and

**WHEREAS**, the Agency wishes to appoint Sykes as CEO effective as of November 2, 2018.

**NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE AGENCY AS FOLLOWS:**

Section 1. The Agency hereby appoints Sykes as CEO effective as of November 2, 2018.


