**WHEREAS**, GARIGLIANO LAW OFFICES, LLP, counsel to the Agency, is disqualified from providing legal services to the Agency in connection with the Project; and

**WHEREAS**, the Agency desires to appoint special transaction counsel to represent the Agency in connection with the Company's application.
