Resolution No. 48 - 22

RESOLUTION AUTHORIZING EXECUTION AND DELIVERY A MORTGAGE TO SECURE A LOAN FROM LIVE OAK BANKING COMPANY (“LENDER”) TO NY MAMAKATING I, LLC (“COMPANY”) IN THE ORIGINAL PRINCIPAL AMOUNT NOT TO EXCEED \$7,675,000

WHEREAS, by Title 1 of Article 18-A of the General Municipal Law of the State of New York ("State"), as amended, and Chapter 560 of the Laws of 1970 of the State, as amended and codified as Section 960 of the General Municipal Law (collectively, the “Act”), the Agency was created with the authority and power to own, lease and sell property as authorized by the Act; and

WHEREAS, by Resolution No. 17-22, adopted May 9, 2022 (“May Resolution”), the Agency appointed the Company as its agent for the purpose of construction of an approximately 3MWac solar photovoltaic electricity generating facility that will be interconnected to the Orange & Rockland Utilities, Inc. electrical grid (“Project”). All capitalized terms not herein defined shall have the respective meaning ascribed thereto in the May Resolution; and

WHEREAS, funds necessary to complete the Project will in part be provided by a loan from Lender to the Company in the original principal amount not to exceed \$7,675,000 (“Loan”); and

WHEREAS, security for the Loan shall include, among other security, a Leasehold, Subleasehold and Sub-Subleasehold Mortgage on the Land; and

WHEREAS, the Agency holds a Leasehold interest in the Land and Project; and

WHEREAS, the Lender requires the Agency to execute for the benefit of the Lender, a Leasehold, Subleasehold and Sub-Subleasehold Mortgage, Security Agreement and Fixture Filing (“Mortgage”), together with such other documents as the Lender may reasonably require; and

WHEREAS, the Agency desires to authorize its Chairperson or Executive Director, each acting individually, to execute the Mortgage and any related documents in favor of Lender as security for the Loan.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE AGENCY AS FOLLOWS:

Section 1. The Chairperson or Executive Director of the Agency, each acting individually, are hereby authorized, on behalf of the Agency, to execute and deliver the Mortgage in favor of Lender in an original principal amount not to exceed \$7,675,000, together with any related financial documents in favor of Lender as security for the Loan.

Section 2. The officers, employees and agents of the Agency are hereby authorized and directed for and in the name and on behalf of the Agency to do all acts and things required and to execute and deliver all such certificates, instruments and documents, to pay all such fees, charges and expenses and to do all such further acts and things as may be necessary or, in the opinion of the officer, employee or agent acting, desirable and proper to effect the purposes of the foregoing resolutions and to cause compliance by the Agency with all of the terms, covenants and provisions of the documents executed for and on behalf of the Agency.

Section 3. This Resolution shall take effect immediately.
